I will remain on the campgrounds for the duration of camp unless the Camp Director has given me permission to leave, and a camp staff member supervises me. _____ (Initial)

I will treat the property of others and the camp with respect. I understand that I am responsible to pay for any property I willfully or recklessly damage, destroy, or steal. _____ (Initial)

I understand that for my safety and the safety of others, camp staff may search my baggage and belongings. I will be present if my items are searched and I will know why the camp has decided to search my belongings. _____ (Initial)

I will turn in any and all medication I bring to the camp nurse/doctor. I understand that the camp nurse/doctor will administer all medication to campers as needed or prescribed. _____ (Initial)

I will wear appropriate clothing while at camp and abide by the camp dress code. None of my clothing will exhibit inappropriate language or images or advertise the use of alcohol, tobacco, drugs, weapons, or violence. I will wear clothing that exhibits Christian modesty and I will abide by the Camp dress code. _____ (Initial)

I will observe all rules posted at camp and verbally communicated during the camp session. _____ (Initial)

I understand that possession or use of alcohol, illicit drugs, controlled substances and weapons are not allowed at any time by anyone. If I have in my possession or use alcohol, drugs, controlled substances or weapons at any point during Ionian Village, I am subject to being sent home immediately at my own/parent's/guardian's expense. _____ (Initial)

I understand that smoking is prohibited throughout all sessions, including trips, and that participants may not smoke at any time, nor may they possess cigarettes, lighters or any smoking materials. _____ (Initial)

I understand that the use of cell phones will be strictly prohibited at camp. They may be used at the airport at the start and end of camp in order to communicate with parents. I understand that my cell phone will be collected at the beginning of camp and returned at the conclusion. _____ (Initial)

I understand that Ionian Village reserves the right to send home any participant who does not follow the guidelines of Ionian Village. Further, I also understand that a parent or guardian may be required to travel to Athens to pick up the participant being sent home, and that any additional transportation costs incurred when arranging early transportation to New York will be charged to the participant and/or his/her family. _____ (Initial)
