## **CONTACT AND ARRIVAL FORM**

This form is to be filled out to inform us of how and when you will be arriving in Greece. We will be at the Athens airport to pick up participants at 11:00 am on Saturday, July 17, 2010. We will require your arriving flight information if you are arriving that morning or contact information if you will already be in Greece. Make note that when the program finishes on Monday, July 26, we will drop off all participants at the Athens airport at 8:00 am. On this form we will also need emergency contact people for your family.

## **HEALTH HISTORY FORM**

The Health History Form needs to be filled out in its entirety for **each** participant in your family. Forms are occasionally lost in transit when being sent, so **please make a copy of the completed form before mailing in**. If anyone in your family has any medical issues or conditions requiring special accommodations at camp, please contact the Ionian Village Family Camp as soon as possible. Please do not allow embarrassment to prevent us from providing necessary care for your family during the camp. The form is confidential and the information is only available to the Camp Directors, the Medical Staff, and staff as needed.

## **MEDIA CONSENT FORM**

Throughout your stay at the Ionian Village Family Camp, staff members will be taking photographs of the participants' activities and posting them on our site. Parents must sign a Media Consent Form granting or denying permission for their family's picture to be taken for promotional materials for the camp and posting pictures on the website.

## **FAMILY CAMP PARTICIPANT AGREEMENT/SOCIAL NETWORKING POLICY**

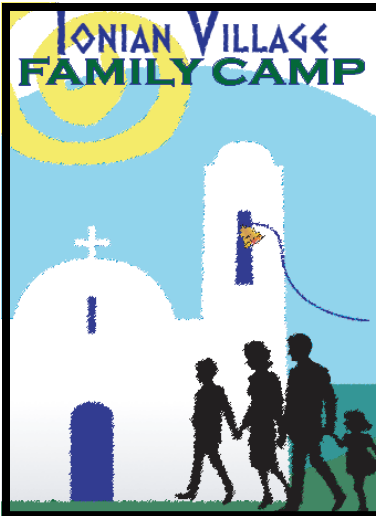
Please ensure that you READ and understand these forms before signing them.

## **INSURANCE CARD COPY**

All camp participants should be covered by their family's insurance policy. While the Ionian Village Family Camp will act as guarantor, any costs incurred by the Camp in providing required treatment for doctor's appointments, prescriptions, etc., will be billed to your family. Please provide our office with a copy of your insurance card front and back.

## **PASSPORT COPIES**

It is important for us to have two copies of each of your family members' passports (inside page with picture and signature) in case it is lost or misplaced.



# FAMILY PARTICIPANT AGREEMENT

**Please be certain that you have READ and UNDERSTAND this document PRIOR to signing it and review the pertinent items with your children.**

We will come to Ionian Village with an open mind and heart, ready to participate in all aspects of the program to the best of our ability.

We will treat the clergy, our staff members, our fellow campers, and visitors with respect while at Ionian Village Family Camp. We will use appropriate language and will not curse, use obscene hand gestures, or participate in vulgar conversations. We also understand that fighting, "rough housing", and physical or verbal bullying and any type of harassment are strictly prohibited and may result in our family being asked to leave camp.

We will treat the property of others and the camp with respect. We understand that we are responsible to pay for any property we willfully or recklessly damage, destroy, or steal.

We understand that possession or use of illicit drugs, controlled substances and weapons are not allowed at any time by anyone. If we have in our possession or use drugs, controlled substances or weapons at any point during Ionian Village Family Camp, our family will be asked to leave camp.

We understand that adults in our family may choose to have an alcoholic beverage when we are off the camp property and that we are responsible for the cost of these beverages. Additionally, should we choose to consume alcohol, we agree to use moderation in this consumption as we understand that intoxication is not appropriate.

We understand that smoking is prohibited during all group activities on the camp property as well as on trips. For adults in our family that need to smoke, we understand that there is a designated place on the camp property to do so and that this is the only place we will smoke while at Ionian Village. On excursions, if smoking becomes necessary we will do so away from the group.

We understand that we are ultimately responsible for our family's participation in the Ionian Village Family Camp program. Should we be running late for a trip departure, it is not the camp staffs' responsibility to make the group wait. If we miss a departure, we are responsible for making our own arrangements to catch up with the group or do our own activity that day. If we choose to stay at camp and not go on a planned trip we understand that we are responsible for making our own arrangements for food and any transportation needs. We are solely responsible for any expenses incurred during this time.

We understand that our promptness is critical for all aspects of the Ionian Village Family Camp program. If my family is late arriving at the airport to depart to the Ionian Village due to circumstances other than a delayed flight, it will be our responsibility to get to the Ionian Village and we will be solely responsible for these expenses.

In addition, when our family is given free time on trips, we understand that if we do not meet back at the designated site and time, it will be our responsibility to get back to the Ionian Village and we will be solely responsible for these expenses.

We understand the program ends on July 26, 2010 at 8:00 am with all participants being dropped off at the Athens airport. Should we need to get to the airport earlier, later or be going somewhere other than the airport we are responsible for making our own travel arrangements and are solely responsible for these expenses.

We understand that the right is reserved to make changes to the activities or events during Ionian Village Family Camp for the safety, comfort, or convenience of the participants of the group, whenever, in sole judgment of the director, such changes are deemed necessary.

We understand that no responsibility is incurred by the Ionian Village Family Camp—Greek Orthodox Archdiocese of America, its leaders, employees, and volunteer staff, for loss of documents, such as passports, or damage to luggage or any personal belongings.

We understand that all reasonable safety precautions will be taken at all times by the Ionian Village Family Camp and its agents during the summer camp and travel program. We understand the possibility of unforeseen hazards and know the inherent possibility of risk. We agree not to hold Ionian Village Family Camp— Greek Orthodox Archdiocese of America, its leaders, employees, and volunteer staff liable for damages, losses, diseases, or injuries incurred by the subject of this form.

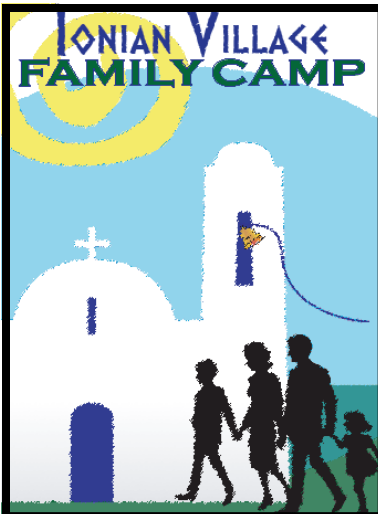

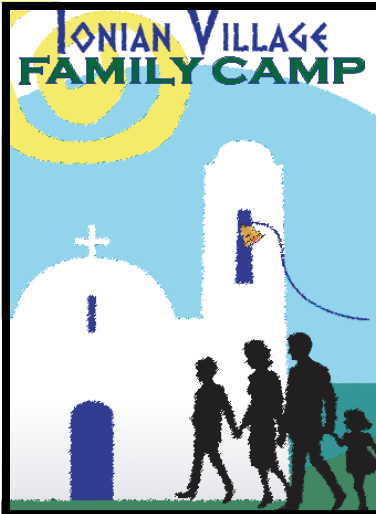

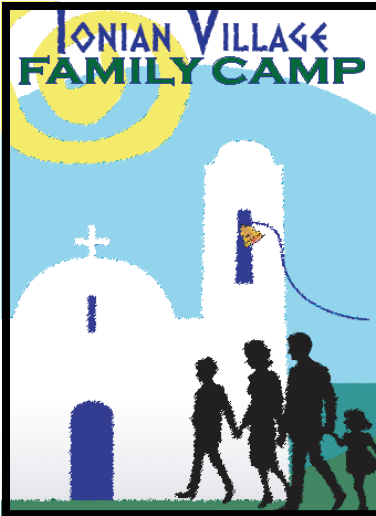

# Family Social Networking Policy

In general, the Ionian Village views social networking sites (e.g., MySpace, Facebook, etc.), personal Web sites, and Weblogs positively and respects the right of camp participants to use them as a medium of self-expression.

If a camp participant chooses to identify himself or herself as a participant at the Ionian Village Family Camp on such Internet venues, some readers of such Web sites or blogs may view the camper as a representative or spokesperson of the Ionian Village Family Camp.

In light of this possibility, the Ionian Village Family Camp requires, as a condition of participation in the camp, that participants observe the following guidelines when referring to the Ionian Village Family Camp, its programs or activities, its campers, and/or other staff, in a blog or on a Web site:

- Camp participants must be respectful in all communications (text and photos) and blogs related to or referencing the camp, its employees, and other campers. Any photos or messages that are linked or “tagged” from “friends” and attached to your site(s) or profile(s) that are inappropriate should also be removed.
- Camp participants must not use obscenities, profanity, or vulgar language.
- Camp participants must not use blogs or personal Web sites to disparage the Ionian Village Family Camp, other campers, or staff of the Ionian Village Family Camp.
- Camp participants must not use blogs or personal Web sites to harass, bully, or intimidate other campers or staff of the Ionian Village Family Camp. Behaviors that constitute harassment and bullying include, but are not limited to, comments that are derogatory with respect to race, religion, gender, sexual orientation, color, or disability; sexually suggestive, humiliating, or demeaning comments; and threats to stalk, haze, or physically injure another person.
- Camp participants must not use these venues to discuss engaging in conduct prohibited by camp policies and an Orthodox Christian lifestyle, including, but not limited to, the use of alcohol and drugs, sexual behavior, sexual harassment, and bullying.
